The petition filed in this cause by defendant Ian Michael Smith on 12 July 2013 and designated 'Petition for Writ of Certiorari' is hereby allowed to permit review of the judgments entered on or about 20 April 2012.

The Guilford County Superior Court shall determine whether defendant is entitled: (1) to the appointment of counsel; (2) to proceed as an indigent; (3) to a copy of the transcript at the expense of the State; and (4) to be released on bond pending appeal. The appeal shall be deemed taken as of the date the superior court determines whether defendant is entitled to the appointment of counsel. The record on appeal shall thereafter be settled as provided in Appellate Rule 11 and filed with this Court as provided by Appellate Rule 12.

A copy of this order shall be mailed to the senior resident superior court judge and the district attorney for the Eighteenth Judicial District and to Appellate Defender Staples Hughes.
