The petition filed in this cause by defendant Michael Gene Hardy on 23 July 2013 and designated 'Petition for a Writ of Certiorari' is allowed for the purpose of entering the following order: It appearing that an evidentiary hearing is necessary to resolve defendant's claim in his motion for appropriate relief filed 21 June 2013 that his guilty plea entered in the above file numbers was improperly taken because he did not sign his Transcript of Plea form, the 24 June 2013 order of Judge Benjamin G. Alford denying defendant's motion for appropriate relief is hereby vacated in part and this matter is remanded for an evidentiary hearing on that claim. Pursuant to N.C. Gen. Stat. 7A-451 (a)(3), the superior court shall appoint counsel to represent defendant if he is determined to be indigent. In all other respects, the petition is denied.
