The petition filed in this cause by defendant on 26 November 2013 and designated 'Petition for a Writ of Certiorari' is allowed for the purpose of granting defendant a belated appeal from the judgment dated 27 March 2013 and entered by Judge Howard E. Manning Jr. in the above file numbers. The Wake County Superior Court shall hold a hearing to determine whether defendant is entitled: (1) to the appointment of counsel; (2) to proceed as an indigent; (3) to a copy of the transcript at the expense of the State; and (4) to be released on bond pending appeal. The appeal shall be deemed taken as of the date of the court's determination of whether defendant is entitled to appointment of counsel. The record on appeal shall thereafter be settled as provided by N.C.R. App. P. 11 and shall be filed in this Court as provided by N.C.R. App. P. 12.

A copy of this order shall be mailed to the Senior Resident Superior Court Judge and the District Attorney of Judicial District 10, and Appellate Defender Staples Hughes.
