The petition filed in this cause by defendant on 12 December 2013 and designated 'Petition for Writ of Certiorari' is allowed as follows. A writ of certiorari is hereby issued to review the 28 May 2013 order of Judge Benjamin G. Alford requiring defendant to enroll in satellite based monitoring. The superior court shall determine whether defendant is entitled to proceed as an indigent, and if it so determines, shall appoint counsel and enter other appropriate orders. The appeal shall be deemed taken as of the date of the superior court's determination of whether defendant is entitled to appointment of counsel. The record on appeal shall thereafter be settled as provided by N.C.R. App. P. 11 and shall be filed in this Court as provided by N.C.R. App. P. 12.

A copy of this order shall be mailed to the Senior Resident Superior Court Judge and the District Attorney of Judicial District 3B.
