The following order was entered:

The motion filed in this cause by defendant on 15 March 2017 and designated 'Notification of Decision by North Carolina Supreme Court' is decided as follows: On 20 December 2013, this Court allowed defendant's petition for writ of certiorari to review Judge James Floyd Ammons, Jr.'s 2 December 2013 order denying defendant's motion for appropriate relief seeking resentencing. Defendant's appeal was held in abeyance pending determination of State v. Young (80A14), State v. Seam (82A14) and State v. Perry (81A14) by the North Carolina Supreme Court. On 21 December 2016, the North Carolina Supreme Court filed decisions in each case holding that Miller v. Alabama, 567 U.S. ___, 183 L.Ed.2d 407(2012), is retroactive and remanding for resentencing. See State v. Young, ___ N.C. ___, 794 S.E.2d 274(2016); State v. Seam, ___ N.C. ___, 794 S.E.2d 439(2016); and State v. Perry ___ N.C. ___, 794 S.E.2d 280 (2016).

It is therefore ordered the trial court's order denying defendant's motion for appropriate relief is reversed and this case be remanded to the Superior Court, Cumberland County, for proceedings not inconsistent with our Supreme Court's holdings in State v. Young, State v. Seam, and State v. Perry.
