The following order was entered:

The petition for writ of certiorari filed by defendant on 27 December 2013 is allowed for the purpose of reviewing the order signed by Judge Charles H. Henry on 31 December 2012 denying his motion for appropriate relief. Our review shall be limited to the issue of whether the evidence at trial supported the trial court's entry of judgment on two counts of first-degree felony murder. See State v. Weeks, 322 N.C. 152, 176, 367 S.E. 2d 895, 909 (1988). The superior court shall hold a hearing to determine whether defendant is entitled to appointment of counsel and to proceed as an indigent. The appeal shall be deemed taken on the date of the court's determination of whether defendant is entitled to appointed counsel. The record on appeal shall thereafter be settled and filed in accordance with the Rules of Appellate Procedure.

A copy of this order shall be mailed to the senior resident superior court judge and the district attorney of Judicial District 4B, and to Appellate Defender Staples Hughes.
