The petition filed in this cause by defendant on 3 January 2014 and designated 'Petition for Writ of Certiorari' is allowed as follows. A writ of certiorari is hereby issued to review the 7 March 2013 judgment of Judge Paul C. Ridgeway. The superior court shall determine whether defendant is entitled: (1) to the appointment of counsel; (2) to proceed as an indigent; (3) to a copy of the transcript at the expense of the State; and (4) to be released on bond pending appeal. The appeal shall be deemed taken as of the date of the superior court's determination of whether defendant is entitled to appointment of counsel. The record on appeal shall thereafter be settled as provided by N.C. R. App. P. 11 and shall be filed in this Court as provided by N.C.R. App. P. 12.

A copy of this order shall be mailed to the Senior Resident Superior Court Judge and the District Attorney of Judicial District 10 and to Appellate Defender Staples Hughes.
