The petition filed in this cause by defendant on 27 March 2014 and designated 'Petition for Writ of Certiorari' is allowed for the purpose of reviewing the judgment entered 7 November 2013 by Judge James M. Webb. The issues that defendant may present on appeal are limited to those to which he originally had an appeal of right. See N.C. Gen. Stat. 15A-1444 (a1), (a2) and (e).

The Guilford County Superior Court shall hold a hearing to determine whether defendant is entitled: (1) to the appointment of counsel; (2) to proceed as an indigent; (3) to a copy of the transcript at the expense of the State; and (4) to be released on bond pending appeal. The appeal shall be deemed taken as of the date of the superior court's determination of whether defendant is entitled to appointment of counsel. Thereafter the record on appeal shall be settled as provided by Appellate Rule 11 and shall be filed in this Court as provided by Appellate Rule 12.

A copy of this order shall be mailed to the senior resident superior court judge and the district attorney of the 18th Judicial District and to Appellate Defender Staples S. Hughes.
