The petition filed by defendant Warren R. Pettiford on 30 April 2014 and designated 'Petition for Writ of Certiorari' is hereby allowed to permit review of the judgment entered 16 May 2013. The Beaufort County Superior Court shall determine whether defendant is entitled: (1) to the appointment of counsel; (2) to proceed as an indigent; (3) to a copy of the transcript at the expense of the State; and (4) to be released on bond pending appeal. The appeal shall be deemed taken as of the date the superior court determines whether defendant is entitled to the appointment of counsel. The record on appeal shall thereafter be settled as provided in Appellate Rule 11 and filed with this Court as provided by Appellate Rule 12. A copy of this order shall be mailed to the senior resident superior court judge and the district attorney for the Second Judicial District and to Appellate Defender Staples Hughes.
