The following order was entered:

The petition for writ of certiorari filed in this cause by defendant on 13 June 2014 is allowed in part for the purpose of reviewing the judgment entered 6 June 2013 by Judge James W. Morgan in 07 CRS 53412. In all other respects, the petition is denied.

The superior court shall hold a hearing to determine whether defendant is entitled: (1) to appointment of counsel; (2) to proceed as an indigent; (3) to a copy of the transcript at State expense; and (4) to release on bond pending appeal. The appeal shall be deemed taken as of the date of the trial court's determination of whether defendant is entitled to appointment of counsel. The record on appeal shall thereafter be settled as provided by N.C.R. App. P. 11 and filed in this Court as provided by N.C.R. App. P. 12.

A copy of this order shall be mailed to the Senior Resident Superior Court Judge and the District Attorney of Judicial District 27B, and to Appellate Defender Staples Hughes.
