The petition filed in this cause by Defendant on 13 June 2014 and designated 'Petition for Writ of Certiorari' is allowed for the purpose of reviewing the judgments entered 14 February 2013 by Judge James E. Hardin, Jr. in Alamance County Superior Court. The Superior Court, Alamance County, shall determine whether Defendant is entitled: (1) to the appointment of counsel; (2) to proceed as an indigent; (3) to a copy of the transcript at the expense of the State; and (4) to be released on bond pending appeal. The appeal shall be deemed taken as of the date of the trial court's determination of whether Defendant is entitled to the appointment of counsel. The record on appeal shall thereafter be settled in accordance with N.C.R. App. P. 11 and shall be filed in this Court in accordance with N.C.R. App. P. 12.

A copy of this order shall be mailed to the Senior Resident Superior Court Judge and the District Attorney of Judicial District Fifteen-A, and Staples S. Hughes, Appellate Defender.
