The following order was entered:

The petition for writ of certiorari filed in this cause by defendant on 10 July 2014 is allowed for the purpose of reviewing the judgment entered 11 April 2013 by Judge J. Thomas Davis. The Superior Court, Cleveland County, shall hold a hearing to determine whether defendant is entitled: (1) to the appointment of counsel; (2) to proceed as an indigent; (3) to a copy of the transcript at the expense of the State; and (4) to be released on bond pending appeal. The appeal shall be deemed taken as of the date of the superior court's determination of whether defendant is entitled to appointment of counsel. The record on appeal shall thereafter be settled in accordance with N.C.R. App. P. 11 and shall be filed in this Court in accordance with N.C.R. App. P. 12.

A copy of this order shall be mailed to: (1) the Senior Resident Superior Court Judge of the 27B Judicial District; (2) the District Attorney of the 27B Judicial District; and (3) Staples S. Hughes, Appellate Defender.
