The petition filed in this cause by defendant Solomon W. Anderson on 22 July 2014 and designated 'Petition for Writ of Certiorari' is hereby allowed as follow: It appearing that defendant was improperly ordered to submit to lifetime registration as a sex offender based on an erroneous finding that second-degree sexual offense is an aggravated offense, Judge Ronald L. Stephens' 8 October 2010 sex offender registration order is reversed, and the matter is remanded for a new hearing to determine defendant's sex offender registration status. The Franklin County Superior Court shall determine whether defendant is entitled: (1) to proceed as an indigent; and (2) to the appointment of counsel. A copy of this order shall be mailed to the senior resident superior court judge and the district attorney for Judicial District Nine.
