The following order was entered:

The petition for writ of certiorari filed by defendant on 22 July 2014 is allowed as follows: It appearing that defendant was ordered to enroll in satellite-based monitoring for the remainder of his natural life based on an erroneous finding that he was convicted of an aggravated offense, the orders as to satellite-based monitoring entered by Judge Forest D. Bridges on 4 May 2009 are hereby vacated. The cause is remanded for a hearing to determine whether defendant shall be ordered to enroll in satellite-based monitoring 'for a period of time to be specified by the court.' N.C. Gen. Stat. 14-208.40B(c) (2013). The trial court shall determine whether defendant is entitled: (1) to proceed as an indigent; and (2) to the appointment of counsel.

A copy of this order shall be mailed to the Senior Resident Superior Court Judge and the District Attorney for Judicial District 27B.
