The following order was entered:

The petition filed in this cause by defendant Lawrence Keith McGee on 11 August 2014 and designated 'Petition for Writ of Certiorari' is hereby allowed to permit appellate review of Judge L. Todd Burke's 8 July 2014 order denying petitioner's motion for appropriate relief. The scope of the appeal shall be limited to the issues raised in petitioner's 28 March 2014 motion for appropriate relief.

The Forsyth County Superior Court shall determine whether defendant is entitled: (1) to the appointment of counsel; (2) to proceed as an indigent; (3) to a copy of the transcript at the expense of the State; and (4) to be released on bond pending appeal. The appeal shall be deemed taken as of the date the superior court determines whether defendant is entitled to the appointment of counsel. The record on appeal shall thereafter be settled as provided in Appellate Rule 11 and filed with this Court as provided by Appellate Rule 12. A copy of this order shall be mailed to the senior resident superior court judge and the district attorney for the Twenty-First Judicial District and to Appellate Defender Staples Hughes.
