The petition filed in this cause by defendant Ar-Raqib Hardy on 1 October 2014 and designated 'Petition for Writ of Certiorari' is allowed for the purpose of reviewing the judgment entered on 1 May 2013 by Judge John E. Nobles, Jr. The Superior Court, Wayne County, shall determine whether defendant is entitled (1) to proceed as an indigent, (2) to the appointment of counsel, (3) to a copy of the transcript at the expense of the State, and (4) to be released on bond pending appeal. The appeal shall be deemed taken as of the date of the trial court's determination of whether defendant is entitled to appointment of counsel. The record on appeal shall thereafter be settled as provided in Appellate Rule 11 and filed in this Court as provided by Appellate Rule 12. A copy of this order shall be mailed to the Senior Resident Superior Court Judge of Judicial District 8, the District Attorney, and Appellate Defender Staples S. Hughes.
