The petition filed in this cause by defendant on 23 October 2014 and designated 'Petition for Writ of Certiorari' is allowed for the purpose of reviewing the judgments entered in the above file numbers on 17 January 2014 by Judge Eric L. Levinson. The Superior Court, Lincoln County, shall hold a hearing to determine whether defendant is entitled: (1) to the appointment of counsel; (2) to proceed as an indigent; (3) to be released on bond pending appeal; and (4) to a copy of the transcript at the expense of the State. The appeal shall be deemed taken as of the date of the trial court's determination of whether defendant is entitled to appointment of counsel. The record on appeal shall thereafter be settled as provided by N.C.R. App. P. 11 and shall be filed in this Court as provided by N.C.R. App. P. 12.

A copy of this order shall be mailed to the Senior Resident Superior Court Judge and the District Attorney of Judicial District 27B and Appellate Defender Staples Hughes.
