The petition for writ of certiorari filed in this cause by defendant on 23 January 2015 is allowed for the purpose of reviewing the judgment entered 16 April 2014 by Judge Thomas H. Lock. The superior court shall hold a hearing to determine whether defendant is entitled: (1) to the appointment of counsel; (2) to proceed as an indigent; (3) to a copy of the transcript at State expense; and (4) to be released on bond pending appeal. The appeal shall be deemed taken as of the date of the trial court's determination of whether defendant is entitled to appointment of counsel. The record on appeal shall thereafter be settled as provided by N.C.R. App. P. 11 and shall be filed in this Court as provided by N.C.R. App. P. 12.
