The following order was entered:

The petition filed in this cause by defendant on 15 May 2015 and designated 'Petition for Writ of Certiorari' is allowed as follows. A writ of certiorari is hereby issued to review the 11 July 2012 judgments of Judge Abraham P. Jones. The superior court shall determine whether defendant is entitled: (1) to the appointment of counsel; (2) to proceed as an indigent; (3) to a copy of the transcript at the expense of the State; and (4) to be released on bond pending appeal. The appeal shall be deemed taken as of the date of the superior court's determination of whether defendant is entitled to appointment of counsel. The record on appeal shall thereafter be settled as provided by N.C.R. App. P. 11 and shall be filed in this Court as provided by N.C.R. App. P. 12. The appeal shall be limited to issues appealable of right pursuant to N.C.Gen. Stat. 15A-1444.

A copy of this order shall be mailed to the Senior Resident Superior Court Judge and the District Attorney of Judicial District 14 and to Appellate Defender Staples Hughes.
