The petition for writ of mandamus filed by Juan Ramirez on 22 February 2016 is allowed for the purpose of entering the following Order: The Senior Resident Superior Court Judge of Judicial District 18 shall direct the Clerk of Superior Court, Guilford County, to produce Petitioner's court file in 06 CRS 102498, State v. Ramirez, so that the judge may ascertain the identity and contact information of the court reporter assigned to Petitioner's trial. The court shall contact the court reporter to determine whether the closing arguments of Petitioner's trial are available for transcription. If the closing arguments are available, the court shall order a transcript provided to Petitioner at his correction institution at State expense. The court shall further provide Petitioner with a copy of the contents of the court file in 06 CRS 102498, including all exhibits and documentary evidence.

Provided, that nothing in this Order shall require the court or the State to provide documents or other material which was previously provided to Petitioner, or which by the exercise of due diligence cannot be located or provided.

A copy of this Order shall be mailed to the Senior Resident Superior Court Judge of Judicial District 18.
