The 'Petition for Writ of Supersedeas and Motion for Temporary Stay' filed by defendant on 27 April 2016 are decided as follows: Because '[p]robation or special probation is stayed' pending appeal, N.C. Gen. Stat. 15A-1451(a)(4)(2015), the petition for writ of supersedeas is allowed. The 'Orders[s] on Violation of Probation' entered by Judge Stuart Albright on 8 February 2016 are hereby stayed. The cause is remanded to the trial court for the purpose of ordering defendant's immediate release from confinement, subject to those conditions, if any, imposed by the court pursuant to N.C. Gen. Stat. 15A-536 (2015). The motion for temporary stay is dismissed as moot.
