The petition filed in this cause by defendant Tonya Leath on 8 June 2016 and designated 'Petition for Writ of Certiorari' is allowed to review the judgment entered 24 April 2015 by Judge G. Wayne Abernathy in Alamance County Superior Court. The Superior Court, Alamance County, shall determine whether petitioner is entitled: (1) to the appointment of counsel; (2) to proceed as an indigent; (3) to a copy of the transcript at the expense of the State; and (4) to be released on bond pending appeal. The appeal shall be deemed taken as of the date of the trial court's determination of whether defendant is entitled to appointment of counsel. The record on appeal shall thereafter be settled in accordance with N.C.R. App. P. 11, and the settled record on appeal shall be filed in this Court in accordance with N. C.R. App. P. 12(a).
