The petition for writ of certiorari filed in this cause by defendant Jesse James Lenoir on 12 September 2016 is allowed for the purpose of reviewing the judgment entered 16 March 2016 by Judge Robert G. Horne. The Rutherford County Superior Court shall determine whether defendant is entitled (1) to proceed as an indigent, (2) to the appointment of counsel, (3) to a copy of the transcript at the expense of the State, and (4) to be released on bond pending appeal. The appeal shall be deemed taken as of the date of the trial court's determination of whether defendant is entitled to appointment of counsel. The record on appeal shall thereafter be settled as provided in Appellate Rule 11 and filed in this Court as provided by Appellate Rule 12. A copy of this order shall be mailed to the Senior Resident Superior Court Judge of Judicial District 29A, the District Attorney, and Appellate Defender Glenn Gerding.
