The motion filed in this cause on the 27th of November 2016 and designated 'Plaintiff-Appellant's Motion to Hold Appellate Proceedings in Abeyance' is allowed. This matter is remanded to the trial court to conduct an evidentiary hearing on the Rule 59(a)/60(b) motion pending before it. Following the taking of evidence, the trial court shall reduce its findings of fact and conclusions of law to writing and shall indicate what action it would be inclined to take were an appeal not pending before this Court. See Bell v. Martin, 43 N.C. App. 134, 140-142, 258 S.E.2d 403, 408-09 (1979), reversed on other grounds, 299 N.C. 715, 264 S.E.2d 101 (1980). The appeal shall be held in abeyance pending the trial court's certification of its findings and conclusions to this Court. The proposed record on appeal shall be served within thirty days of the trial court's certification to this Court.
