The following order was entered:

The petition filed in this cause by defendant on 23 November 2016 and designated 'Petition for Writ of Certiorari' is allowed for the purpose of reviewing the judgment of Judge Todd Pomeroy dated 28 July 2016. The Superior Court, Lincoln County, shall determine whether defendant is entitled: (1) to the appointment of counsel; (2) to proceed as an indigent; (3) to a copy of the transcript at the expense of the State; and (4) to be released on bond pending appeal. The appeal shall be deemed taken as of the date of the trial court's determination of whether defendant is entitled to appointment of counsel. The record on appeal shall thereafter be settled in accordance with N.C.R. App. P. 11, and the settled record on appeal shall be filed in this Court pursuant to N.C.R. App. P. 12.

A copy of this order shall be mailed to the Senior Resident Superior Court Judge and the District Attorney of Judicial District 27B and to Appellate Defender Glenn Gerding.
