The petition filed in this cause by defendant Jason Lewis Riggins on 28 November 2016 and designated 'Petition for Writ of Mandamus' is decided as follows: It appearing that defendant has an appeal of right from the 17 July 2016 order entered in the above file numbers by Judge G. Wayne Abernathy that denied defendant's motion for DNA testing; that defendant is entitled to the appointment of counsel to perfect his appeal if he is found to be indigent; and that defendant filed timely notice of appeal from the order, in which he averred he was indigent and requested the appointment of counsel to perfect his appeal; this matter is remanded to the Superior Court of Alamance County, which is ordered to hold a hearing to determine if defendant is indigent and thus entitled to appointed counsel to represent him in his appeal.
