The petition filed in this cause by defendant John Darren Bullard on 25 January 2017 and designated 'Petition for Writ of Mandamus' is decided as follows: It appearing that defendant has an appeal of right from the 24 August 2016 order entered in the above file number by Judge Robert F. Floyd, Jr. denying defendant's motion for DNA testing; that defendant is entitled to the appointment of counsel to perfect his appeal if he is found to be indigent; and that defendant filed timely notice of appeal from the order, in which he averred he was indigent and requested the appointment of counsel to perfect his appeal; the Superior Court of Robeson County is hereby ordered to determine whether defendant is entitled to proceed as an indigent and to appoint counsel for defendant, if indigent, within thirty days from the date of this order so that defendant may come forward with his appeal.
