The petition filed in this cause by defendant on 26 January 2017 and designated 'Petition for Writ of Certiorari' is allowed for the purpose of reviewing the judgment of Judge R. Allen Baddour, Jr., dated 12 July 2016. The Superior Court, Forsyth County, shall determine whether defendant is entitled: (1) to the appointment of counsel; (2) to proceed as an indigent; (3) to a copy of the transcript at the expense of the State; and (4) to be released on bond pending appeal. The appeal shall be deemed taken as of the date of the trial court's determination of whether defendant is entitled to appointment of counsel. The record on appeal shall thereafter be settled in accordance with N.C.R. App. P. 11, and the settled record on appeal shall be filed in this Court pursuant to N.C.R. App. P. 12.
