The petition filed in this cause by defendant Mark Dwayne Dancy on 2 February 2017 and designated 'Petition for Writ of Certiorari' is allowed to review the judgment entered 19 July 2016 in Cabarrus County Superior Court. The Superior Court, Cabarrus County, shall determine whether petitioner is entitled: (1) to the appointment of counsel; (2) to proceed as an indigent; (3) to a copy of the transcript at the expense of the State; and (4) to be released on bond pending appeal. The appeal shall be deemed taken as of the date of the trial court's determination of whether defendant is entitled to appointment of counsel. The record on appeal shall thereafter be settled in accordance with N.C.R. App. P. 11, and the settled record on appeal shall be filed in this Court in accordance with N.C.R. App. P. 12(a).

A copy of this order shall be mailed to the senior resident superior court judge of judicial district 19A, the district attorney, and Appellate Defender Glenn Gerding.
