By unanimous vote, the "Emergency Motion for Temporary Stay," "Motion to Shorten Time for Response," and "Motion for Leave to File Reply" filed in this cause by defendant-appellants on 6 September 2022 are allowed as follows:

The "Preliminary Injunction and Writ of Mandamus" entered by Judge James F. Ammons, Jr., on 2 September 2022 is hereby stayed pending this Court's ruling on defendant-appellants' petition for writ of supersedeas.

By 4:00 p.m. on 8 September 2022, the parties shall submit supplemental filings that (1) discuss the authority of the trial court, if any, to select the date for the special election, and (2) identify the next available dates for the special election under the provisions of N.C.G.S. Section 163-287(a)(1)-(4) (2021) or any other statute they contend applies. Plaintiff-appellees' supplement shall also respond to the merits of defendant-appellants' petition for writ of supersedeas.

In its discretion, this Court will consider defendant-appellants' reply filed on 6 September 2022.
